

## **Federal Ministry of the Interior**

In accordance with Section 3 (1), first sentence, alternatives 2 and 3, in conjunction with Section 17 number 3 of the Act Governing Private Associations (Vereinsgesetz, VereinsG) of 5 August 1964 (Federal Law Gazette I, p. 593), last amended by Article 2 (29) of the Act of 1 April 2015 (Federal Law Gazette I, p. 434), I issue the following

### **Direction:**

1. The association "Die wahre Religion" (DWR) [The true religion] also known as "LIES! Stiftung / Stiftung LIES" [READ! Foundation / Foundation READ"] (hereinafter referred to as DWR), including its sub-organizations "LIES! Verlag" [READ! Publishing House], "ReadLiesLtd" and "Insamlingsstiflesen Al Quran Foundation" is directed against the constitutional order and the idea of international understanding.
2. The association DWR and its sub-organizations mentioned in number 1 shall be banned and dissolved.
3. As long as this ban is in effect, it shall be prohibited to use symbols of the association DWR and its sub-organizations mentioned in number 1 in public, in an assembly or in print, audio or visual media, pictures or portrayals that may or are meant to be disseminated. The prohibition shall extend to the following symbols in particular:

The word LIES with an exclamation mark written in gold capital letters, followed by the word "Stiftung" [foundation].

including their provision, hosting and other use shall be prohibited.

5. The assets of the association DWR shall be confiscated and forfeited to the benefit of the Federation.
6. The property of third parties shall be confiscated and forfeited if the owner, by handing the property over to the association DWR or its sub-organizations mentioned in number 1, supported the association's anti-constitutional activities or if the property was intended to further such activities.
7. Any claims of third parties relative to the association DWR or its sub-organizations mentioned in number 1 shall be confiscated and forfeited if, by their nature, scope or purpose, they deliberately serve to support the anti-constitutional aims of the association, or if they were established to protect assets of the association or its sub-organizations from confiscation by the authorities or to reduce the value of the association's assets or those of its sub-organizations. If a creditor has acquired such a claim by assignment, the claim shall be forfeited if the creditor was aware of the facts stated in the first sentence when acquiring the claim.
8. The immediate enforcement of this direction is hereby ordered; this shall not apply to the forfeiture order.
